Win Revenue Summary – July 2000

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$827,617,138 for the month of July 2000. This amounts to a 12.81% increase compared to July 1999, when licensees reported a gaming win of \$733,644,136.

Percentage Fee Tax Collections for the Month of August 2000

The State collected \$48,799,093 in percentage fee taxes during the month of August 2000, based upon the taxable revenues generated in July 2000. This represents a 6.02% (or \$2,770,671) increase compared to the prior year's August (1999), when percentage fee collections were \$46,028,422.

On a two-month fiscal-year-to-date (July 1, 2000 through August 31, 2000), the State of Nevada collected \$89,075,290 in percentage fee taxes. This represents a 4.33% increase from the prior fiscal year two-month period when collections totaled \$85,377,799.
