**Win Revenue Summary – August 2000**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$814,409,029 for the month of August. This amounts to a **6.72% increase** compared to August 1999, when licensees reported a gaming win of \$763,130,738.

**Percentage Fee Tax Collections for the Month of September 2000**

The State collected \$46,007,616 in percentage fee taxes during the month of September 2000, based upon the taxable revenues generated in August 2000. This represents an 8.98% (or \$3,789,971) increase compared to the prior year's September (1999), when percentage fee collections were \$42,217,645.

On a three-month fiscal-year-to-date (July 1, 2000 through September 30, 2000), the State of Nevada collected \$135,082,906 in percentage fee taxes. This represents a 5.87% increase from the prior fiscal year three-month period when collections totaled \$127,595,444.
