Win Revenue Summary – September 2000

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$788,450,313 for the month of September 2000. This amounts to a **-3.79% decrease** compared to September 1999, when licensees reported a gaming win of \$819,550,441.

Percentage Fee Tax Collections for the Month of October 2000

The State collected \$51,411,184 in percentage fee taxes during the month of October 2000, based upon the taxable revenues generated in September 2000. This represents a 3.97% (or \$1,963,928) increase compared to the prior year's October (1999), when percentage fee collections were \$49,447,256.

On a four-month fiscal-year-to-date (July 1, 2000 through October 31, 2000), the State of Nevada collected \$186,494,090 in percentage fee taxes. This represents a 5.34% increase from the prior fiscal year four-month period when collections totaled \$177,042,700.
