**Win Revenue Summary – November 2000**

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$779,887,170 for the month of November 2000. This amounts to a 3.27% decrease compared to November 1999, when licensees reported a gaming win of \$806,270,461.

**Percentage Fee Tax Collections for the Month of November 2000**

The State collected \$41,362,258 in percentage fee taxes during the month of December 2000, based upon the taxable revenues generated in November 2000. This represents a 14.71% (or \$7,136,341) decrease compared to the prior year's December (1999), when percentage fee collections were \$48,498,599.

On a six-month fiscal-year-to-date (July 1, 2000 through December 31, 2000), the State of Nevada collected \$276,082,468 in percentage fee taxes. This represents a 0.46% increase from the prior fiscal year six-month period when collections totaled \$274,809,628.
