Win Revenue Summary – March 2001

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$858,037,685 for the month of March 2001. This amounts to a **2.59% increase** compared to March 2000, when licensees reported a gaming win of \$836,401,200.

Percentage Fee Tax Collections for the Month of April 2001

The State collected \$68,622,535 in percentage fee taxes during the month of April 2001, based upon the taxable revenues generated in March 2001. This represents a 5.57% (or \$3,621,353) increase compared to the prior year's April (2000), when percentage fee collections were \$65,001,182.

On a ten-month fiscal-year-to-date (July 1, 2000 through April 30, 2001), the State of Nevada collected \$470,297,319 in percentage fee taxes. This represents a .12% decrease from the prior fiscal year ten-month period when collections totaled \$470,872,762.
