Win Revenue Summary – April 2001

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$774,261,758 for the month of April 2001. This amounts to a 1.45% decrease compared to April 2000, when licensees reported a gaming win of \$785,633,673.

Percentage Fee Tax Collections for the Month of May 2001

The State collected \$38,566,538 in percentage fee taxes during the month of May 2001, based upon the taxable revenues generated in April 2001. This represents a 3.56% (or \$1,325,214) increase compared to the prior year's May (2000), when percentage fee collections were \$37,241,324.

On an eleven-month fiscal-year-to-date (July 1, 2000 through May 31, 2001), the State of Nevada collected \$508,787,369 in percentage fee taxes. This represents a .13% increase from the prior fiscal year eleven-month period when collections totaled \$508,114,086.
