Win Revenue Summary – June 2001

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$776,513,252 for the month of June 2001. This amounts to a 3.83% increase compared to June 2000, when licensees reported a gaming win of \$747,887,847.

Percentage Fee Tax Collections for the Month of July 2001

The State collected \$38,055,110 in percentage fee taxes during the month of July 2001, based upon the taxable revenues generated in June 2001. This represents a 5.51% (or \$2,221,087) decrease compared to the prior year's July (2000), when percentage fee collections were \$40,276,197.
