Win Revenue Summary – October 2001

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$769,733,879 for the month of October 2001. This amounts to a 5.12% decrease compared to October 2000, when licensees reported a gaming win of \$811,235,360.

Percentage Fee Tax Collections for the Month of November 2001

The State collected \$44,355,646 in percentage fee taxes during the month of November 2001, based upon the taxable revenues generated in October 2001. This represents an 8.03% (or \$3,870,474) decrease compared to the prior year's October (2000), when percentage fee collections were \$48,226,120.

On a five-month fiscal-year-to-date (July 1, 2001 through November 30, 2001), the State of Nevada collected \$226,911,658 in percentage fee taxes. This represents a 3.33% decrease from the prior fiscal year five-month period when collections totaled \$234,720,210.
