Nevada Gaming Revenues and Collections

Win Revenue Summary – December 2010

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$838,789,136 for the month of December 2010. This amounts to a 2.39% decrease compared to December 2009, when licensees reported a gaming win of \$859,285,985. For the fiscal year (July 1, 2010 through December 31, 2010), gaming win has increased 1.50%.

Percentage Fee Collections for the Month of January 2011

The State collected \$29,995,247 in percentage fees during the month of January 2011, based upon the taxable revenues generated in December 2010. This represents a 10.37% (or \$3,469,896) decrease compared to the prior year's January, when percentage fee collections were \$33,465,143.
