Nevada Gaming Revenues and Collections

Win Revenue Summary – February 2011

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$881,829,244 for the month of February 2011. This amounts to a 6.84% decrease compared to February 2010, when licensees reported a gaming win of \$946,615,024. For the fiscal year (July 1, 2010 through February 28, 2011), gaming win has increased .09%.

Percentage Fee Collections for the Month of March 2011

The State collected \$41,569,870 in percentage fees during the month of March 2011, based upon the taxable revenues generated in February 2011. This represents an 11.11% (or \$5,194,545) decrease compared to the prior year's March, when percentage fee collections were \$46,764,415.
