Nevada Gaming Revenues and Collections

Win Revenue Summary – May 2011

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$984,014,981 for the month of May 2011. This amounts to a 16.16% increase compared to May 2010, when licensees reported a gaming win of \$847,136,303. For the fiscal year (July 1, 2010 through May 31, 2011), gaming win has increased 1.94%.

Percentage Fee Collections for the Month of June 2011

The State collected \$68,320,952 in percentage fees during the month of June 2011, based upon the taxable revenues generated in May 2011. This represents a 17.64% (or \$10,245,639) increase compared to the prior year's June, when percentage fee collections were \$58,075,313.
