**Win Revenue Summary – October 2011**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$960,687,873 for the month of October 2011. This amounts to an 8.12% increase compared to October 2010, when licensees reported a gaming win of \$888,569,153.

**Percentage Fee Collections for the Month of November 2011**

The State collected \$65,354,308 in percentage fees during the month of November 2011, based upon the taxable revenues generated in October 2011. This represents an 8.64% (or \$5,194,900) increase compared to the prior year's November, when percentage fee collections were \$60,159,408.
