Nevada Gaming Revenues and Collections

Win Revenue Summary – January 2012

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,038,406,572 for the month of January 2012. This amounts to an 18.37% increase compared to January 2011, when licensees reported a gaming win of \$877,281,553. For the fiscal year (July 1, 2011 through January 31, 2012), gaming win has increased 3.69%.

Percentage Fee Collections for the Month of February 2012

The State collected \$57,392,681 in percentage fees during the month of February 2012, based upon the taxable revenues generated in January 2012. This represents a 16.53% (or \$11,366,173) decrease compared to the prior year's February, when percentage fee collections were \$68,758,854.
