**Nevada Gaming Revenues and Collections**

**Win Revenue Summary – April 2012**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$855,707,815 for the month of April 2012. This amounts to a 6.16% increase compared to April 2011, when licensees reported a gaming win of \$806,072,327. For the fiscal year (July 1, 2011 through April 30, 2012), gaming win has increased 2.53%.

**Percentage Fee Collections for the Month of May 2012**

The State collected \$48,565,324 in percentage fees during the month of May 2012, based upon the taxable revenues generated in April 2012. This represents a 13.98% (or \$5,957,714) increase compared to the prior year's May, when percentage fee collections were \$42,607,610.
