Nevada Gaming Revenues and Collections

Win Revenue Summary – February 2013

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,073,255,958 for the month of February 2013. This amounts to a 15.13% increase compared to February 2012, when licensees reported a gaming win of \$932,175,507. For the fiscal year (July 1, 2012 through February 28, 2013), gaming win has increased 2.29%.

Percentage Fee Collections for the Month of March 2013

The State collected \$61,769,051 in percentage fees during the month of March 2013, based upon the taxable revenues generated in February 2013. This represents a 12.22% (or \$8,596,802) decrease compared to the prior year's March, when percentage fee collections were \$70,365,853.
