Nevada Gaming Revenues and Collections

Win Revenue Summary – April 2022

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,128,480,917 for the month of April 2022. This amounts to an 8.57% <u>increase</u> compared to April 2021, when licensees reported a gaming win of \$1,039,358,922. For the fiscal year (July 1, 2021 through April 30, 2022), gaming win has increased 46.26%.

Percentage Fee Collections for the Month of May 2022

The State collected \$69,862,415 in percentage fees during the month of May 2022*, based upon the taxable revenues generated in April 2022. This represents a 12.09% (or \$9,603,814) decrease compared to the prior year's May, when percentage fee collections were \$79,466,229.
