Nevada Gaming Revenues and Collections

Win Revenue Summary – November 2022

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,220,869,734 for the month of November 2022. This amounts to a 7.62% <u>decrease</u> compared to November 2021, when licensees reported a gaming win of \$1,321,592,551. For the fiscal year (July 1, 2022 through November 30, 2022), gaming win has increased 0.76%.

Percentage Fee Collections for the Month of December 2022

The State collected \$77,960,271 in percentage fees during the month of December 2022*, based upon the taxable revenues generated in November 2022. This represents a 17.06% (or \$16,038,022) <u>decrease</u> compared to the prior year's December, when percentage fee collections were \$93,998,293.
