Nevada Gaming Revenues and Collections

Win Revenue Summary – January 2023

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,272,955,068 for the month of January 2023. This amounts to a 17.99% <u>increase</u> compared to January 2022, when licensees reported a gaming win of \$1,078,835,479. For the fiscal year (July 1, 2022 through January 31, 2023), gaming win has increased 4.81%.

Percentage Fee Collections for the Month of February 2023

The State collected \$96,100,468 in percentage fees during the month of February 2023*, based upon the taxable revenues generated in January 2023. This represents a 17.86% (or \$14,565,192) increase compared to the prior year's February, when percentage fee collections were \$81,535,276.
