## Win Revenue Summary – June 2023

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,245,814,727 for the month of June 2023. This amounts to a 2.44% <u>decrease</u> compared to June 2022, when licensees reported a gaming win of \$1,277,029,261. For the fiscal year (July 1, 2022 through June 30, 2023), gaming win has increased 3.25%.

## Percentage Fee Collections for the Month of July 2023

The State collected \$78,561,494 in percentage fees during the month of July 2023\*, based upon the taxable revenues generated in June 2023. This represents a 1.45% (or \$1,122,776) increase compared to the prior year's July, when percentage fee collections were \$77,438,718.
