Nevada Gaming Revenues and Collections

Win Revenue Summary – April 2024

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,240,195,370 for the month of April 2024. This amounts to a 6.95% increase compared to April 2023, when licensees reported a gaming win of \$1,159,587,987. For the fiscal year (July 1, 2023 through April 30, 2024), gaming win has increased 4.67%.

PRESS RELEASE

Percentage Fee Collections for the Month of May 2024

The State collected \$70,273,837 in percentage fees during the month of May 2024*, based upon the taxable revenues generated in April 2024. This represents a 4.18% (or \$2,820,025) increase compared to the prior year’s May, when percentage fee collections were \$67,453,812.
