Nevada Gaming Revenues and Collections

Win Revenue Summary – August 2024

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,163,739,235 for the month of August 2024. This amounts to a 3.80% decrease compared to August 2023, when licensees reported a gaming win of \$1,209,702,164. For the fiscal year (July 1, 2024 through August 31, 2024), gaming win has decreased 5.47%.

Percentage Fee Collections for the Month of September 2024

The State collected \$57,672,613 in percentage fees during the month of September 2024*, based upon the taxable revenues generated in August 2024. This represents a 23.93% (or \$18,138,403) decrease compared to the prior year's September, when percentage fee collections were \$75,811,016.
