Nevada Gaming Revenues and Collections

Win Revenue Summary – July 2024

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,306,786,985 for the month of July 2024. This amounts to a 6.91% decrease compared to July 2023, when licensees reported a gaming win of \$1,403,811,560.

Percentage Fee Collections for the Month of August 2024

The State collected \$95,890,921 in percentage fees during the month of August 2024*, based upon the taxable revenues generated in July 2024. This represents a 0.20% (or \$192,775) decrease compared to the prior year's August, when percentage fee collections were \$96,083,696.
