Nevada Gaming Revenues and Collections

Win Revenue Summary – June 2024

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,286,686,312 for the month of June 2024. This amounts to a 3.26% increase compared to June 2023, when licensees reported a gaming win of \$1,246,020,144. For the fiscal year (July 1, 2023 through June 30, 2024), gaming win has increased 4.36%.

Percentage Fee Collections for the Month of July 2024

The State collected \$66,929,725 in percentage fees during the month of July 2024*, based upon the taxable revenues generated in June 2024. This represents a 20.24% (or \$16,979,488) decrease compared to the prior year's July, when percentage fee collections were \$83,909,213.
