Nevada Gaming Revenues and Collections

Win Revenue Summary – May 2024

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,320,410,216 for the month of May 2024. This amounts to a 2.45% <u>increase</u> compared to May 2023, when licensees reported a gaming win of \$1,288,836,996. For the fiscal year (July 1, 2023 through May 31, 2024), gaming win has increased 4.46%.

Percentage Fee Collections for the Month of June 2024

The State collected \$88,492,844 in percentage fees during the month of June 2024*, based upon the taxable revenues generated in May 2024. This represents an 11.97% (or \$9,457,695) increase compared to the prior year's June, when percentage fee collections were \$79,035,149.
