Nevada Gaming Revenues and Collections

Win Revenue Summary – November 2024

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,316,462,271 for the month of November 2024. This amounts to a 4.21% decrease compared to November 2023 when licensees reported a gaming win of \$1,374,357,540. For the fiscal year (July 1, 2024 through November 30, 2024), gaming win has decreased 2.85%.

PRESS RELEASE

Percentage Fee Collections for the Month of December 2024

The State collected \$87,171,944 in percentage fees during the month of December 2024, based upon the taxable revenues generated in November 2024. This represents a 1.50% (or \$1,287,379) increase compared to the prior year’s December, when percentage fee collections were \$85,884,565.
