Nevada Gaming Revenues and Collections

Win Revenue Summary – September 2024

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,312,902,449 for the month of September 2024. This amounts to a 3.34% increase compared to September 2023, when licensees reported a gaming win of \$1,270,415,924. For the fiscal year (July 1, 2024 through September 30, 2024), gaming win has decreased 2.59%.

Percentage Fee Collections for the Month of October 2024

The State collected \$99,428,847 in percentage fees during the month of October 2024*, based upon the taxable revenues generated in September 2024. This represents a 32.37% (or \$24,313,764) increase compared to the prior year's October, when percentage fee collections were \$75,115,083.
