January 2025 **Nevada Gaming Revenues and Collections**

Win Revenue Summary – January 2025

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,439,329,029 for the month of January 2025. This amounts to a 12.54% increase compared to January 2024 when licensees reported a gaming win of \$1,278,919,728. For the fiscal year (July 1, 2024 through January 31, 2025), gaming win has increased 0.03%.

Percentage Fee Collections for the Month of February 2025

The State collected \$108,687,470 in percentage fees during the month of February 2025*, based upon the taxable revenues generated in January 2025. This represents an 8.99% (or \$8,967,912) increase compared to the prior year's February, when percentage fee collections were \$99,719,558.
