Nevada Gaming Revenues and Collections

Win Revenue Summary – June 2025

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,332,354,924 for the month of June 2025. This amounts to a 3.53% increase compared to June 2024, when licensees reported a gaming win of \$1,286,954,701. For the fiscal year (July 1, 2024 through June 30, 2025), gaming win has decreased 0.79%.

Percentage Fee Collections for the Month of July 2025

The State collected \$83,715,030 in percentage fees during the month of July 2025*, based upon the taxable revenues generated in June 2025. This represents a 20.14% (or \$14,033,438) increase compared to the prior year's July, when percentage fee collections were \$69,681,592.
