Nevada Gaming Revenues and Collections

Win Revenue Summary – May 2025

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,291,726,422 for the month of May 2025. This amounts to a 2.18% <u>decrease</u> compared to May 2024 when licensees reported a gaming win of \$1,320,454,281. For the fiscal year (July 1, 2024 through May 31, 2025), gaming win has decreased 1.18%.

Percentage Fee Collections for the Month of June 2025

The State collected \$79,215,052 in percentage fees during the month of June 2025*, based upon the taxable revenues generated in May 2025. This represents an 7.67% (or \$6,582,516) decrease compared to the prior year's June, when percentage fee collections were \$85,797,568.
