April 2002 Nevada Gaming Revenues and Collections

Win Revenue Summary - April 2002

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$800,038,697 for the month of April 2002. This amounts to a 3.09% <u>increase</u> compared to April 2001, when licensees reported a gaming win of \$776,050,768.

Percentage Fee Tax Collections for the Month of May 2002

The State collected \$48,180,810 in percentage fee taxes during the month of May 2002, based upon the taxable revenues generated in April 2002. This represents an 24.93% (or \$9,614,272) increase compared to the prior year's May (2001), when percentage fee collections were \$38,566,538.

On an eleven-month fiscal-year-to-date (July 1, 2001 through May 31, 2002), the State of Nevada collected \$496,771,559 in percentage fee taxes. This represents a 2.36% <u>decrease</u> from the prior fiscal year eleven-month period when collections totaled \$508,787,559.
