# April 2003 Nevada Gaming Revenues and Collections

### Win Revenue Summary – April 2003

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$744,620,432 for the month of April 2003. This amounts to a 6.87% <u>decrease</u> compared to April 2002, when licensees reported a gaming win of \$799,587,360. Comparing back to April 2001, prior to the tragic events of September 11<sup>th</sup> and the accelerated downturn in our tourist-based economy, gaming win declined 4.05%.

### Percentage Fee Tax Collections for the Month of May 2003

The State collected \$39,750,951 in percentage fee taxes during the month of May 2003, based upon the taxable revenues generated in April 2003. This represents a 17.50% (or \$8,429,859) decrease compared to the prior year's May (2002), when percentage fee collections were \$48,180,810.

On an eleven-month fiscal-year-to-date (July 1, 2002 through May 31, 2003), the State of Nevada collected \$509,837,343 in percentage fee taxes. This represents a 2.63% <u>increase</u> from the prior fiscal year eleven-month period when collections totaled \$496,771,559.
