April 2005 Nevada Gaming Revenues and Collections

Win Revenue Summary – April 2005

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$878,217,319 for the month of April 2005. This amounts to a 6.12% <u>increase</u> compared to April 2004, when licensees reported a gaming win of \$827,540,759. For the fiscal year (July 1, 2004 through April 30, 2005), gaming win has increased 8.05%.

Percentage Fee Collections for the Month of May 2005

The State collected \$48,746,442 in percentage fees during the month of May 2005, based upon the taxable revenues generated in April 2005. This represents an 11.87% (or \$6,564,318) decrease compared to the prior year's May (2004), when percentage fee collections were \$55,310,760.
