**Win Revenue Summary – April 2006**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$989,792,512 for the month of April 2006. This amounts to a 12.69% increase compared to April 2005, when licensees reported a gaming win of \$878,294,962 For the fiscal year (July 1, 2005 through April 30, 2006), gaming win has increased 12.50%.

**Percentage Fee Collections for the Month of May 2006**

The State collected \$52,875,759 in percentage fees during the month of May 2006, based upon the taxable revenues generated in April 2006. This represents an 8.47% (or \$4,129,317) increase compared to the prior year's May, when percentage fee collections were \$48,746,442.
