Nevada Gaming Revenues and Collections

Win Revenue Summary – April 2009

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$859,410,113 for the month of April 2009. This amounts to a 14.07% <u>decrease</u> compared to April 2008, when licensees reported a gaming win of \$1,000,148,590. For the fiscal year (July 1, 2008 through April 30, 2009), gaming win has decreased 14.20%.

Percentage Fee Collections for the Month of May 2009

The State collected \$51,839,841 in percentage fees during the month of May 2009, based upon the taxable revenues generated in April 2009. This represents a 5.90% (or \$3,249,291) <u>decrease</u> compared to the prior year's May, when percentage fee collections were \$55,089,132.
