Win Revenue Summary - April 2018

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$953,698,753 for the month of April 2018. This amounts to a 7.57% <u>increase</u> compared to April 2017, when licensees reported a gaming win of \$886,561,704. For the fiscal year (July 1, 2017 through April 30, 2018), gaming win has increased 2.91%.

Percentage Fee Collections for the Month of May 2018

The State collected \$53,399,391 in percentage fees during the month of May 2018*, based upon the taxable revenues generated in April 2018. This represents a 20.66% (or \$9,143,178) increase compared to the prior year's May, when percentage fee collections were \$44,256,213.
