Win Revenue Summary - April 1998

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$653,201,499 for the month of April 1998. This amounts to a 2.72% increase compared to April 1997, when licensees reported a gaming win of \$635,933,170.

**Percentage Fee Tax Collections for the Month of May 1998**

The State collected \$32,754,132 in percentage fee taxes during the month of May 1998, based upon the taxable revenues generated in April 1998. This represents a 3.54% (or \$1,202,723) decrease compared to the prior year's May (1997), when percentage fee collections were \$33,956,855.

On an eleven-month fiscal-year-to-date (July 1, 1997 through May 31, 1998) basis, the State of Nevada collected \$412,236,800 in percentage fee taxes. This represents a 2.99% increase from the prior fiscal year eleven-month period when collections totaled \$400,271,494.
