April 1999 Nevada Gaming Revenues and Collections

Win Revenue Summary - April 1999

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$689,348,902 for the month of April 1999. This amounts to a 5.52% <u>increase</u> compared to April 1998, when licensees reported a gaming win of \$653,275,926.

Percentage Fee Tax Collections for the Month of May 1999

The State collected \$36,814,464 in percentage fee taxes during the month of May 1999, based upon the taxable revenues generated in April 1999. This represents a 12.40% (or \$4,060,332) <u>increase</u> compared to the prior year's May (1998), when percentage fee collections were \$32,754,132.

On an eleven-month fiscal-year-to-date (July 1, 1998 through May 31, 1999), the State of Nevada collected \$448,075,489 in percentage fee taxes. This represents an 8.69% <u>increase</u> from the prior fiscal year eleven-month period when collections totaled \$412,252,791.
