Win Revenue Summary – August 2001

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$824,583,237 for the month of August 2001. This amounts to a 1.23% increase compared to August 2000, when licensees reported a gaming win of \$814,541,659.

Percentage Fee Tax Collections for the Month of September 2001

The State collected \$44,584,029 in percentage fee taxes during the month of September 2001, based upon the taxable revenues generated in August 2001. This represents a 3.09% (or \$1,423,587) decrease compared to the prior year's September (2000), when percentage fee collections were \$46,007,616.

On a three-month fiscal-year-to-date (July 1, 2001 through September 30, 2001), the State of Nevada collected \$136,704,397 in percentage fee taxes. This represents a 1.20% increase from the prior fiscal year three-month period when collections totaled \$135,082,906.
