Nevada Gaming Revenues and Collections

Win Revenue Summary – August 2010

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$944,473,186 for the month of August 2010. This amounts to a 11.51% <u>increase</u> compared to August 2009, when licensees reported a gaming win of \$846,957,648. For the fiscal year (July 1, 2010 through August 31, 2010), gaming win has increased 3.17%.

Percentage Fee Collections for the Month of September 2010

The State collected \$61,762,179 in percentage fees during the month of September 2010, based upon the taxable revenues generated in August 2010. This represents a 24.4% (or \$12,114,739) <u>increase</u> compared to the prior year's September, when percentage fee collections were \$49,647,440.
