Nevada Gaming Revenues and Collections

Win Revenue Summary – August 2011

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$886,861,912 for the month of August 2011. This amounts to a 6.10% <u>decrease</u> compared to August 2010, when licensees reported a gaming win of \$944,457,344.

Percentage Fee Collections for the Month of September 2011

The State collected \$47,168,051 in percentage fees during the month of September 2011, based upon the taxable revenues generated in August 2011. This represents a 23.63% (or \$14,594,128) decrease compared to the prior year's September, when percentage fee collections were \$61,762,179.
