Nevada Gaming Revenues and Collections

Win Revenue Summary – August 2014

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$920,291,644 for the month of August 2014. This amounts to a 3.66% decrease compared to August 2013, when licensees reported a gaming win of \$955,231,126. For the fiscal year (July 1, 2014 through August 31, 2014), gaming win has decreased 1.53%.

Percentage Fee Collections for the Month of September 2014

The State collected \$50,729,483 in percentage fees during the month of September 2014*, based upon the taxable revenues generated in August 2014. This represents a -1.25% (or \$642,046) decrease compared to the prior year's August, when percentage fee collections were \$51,371,529.
