### **Nevada Gaming Revenues and Collections**

# Win Revenue Summary – August 2017

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$989,510,649 for the month of August 2017. This amounts to a 14.91% <u>increase</u> compared to August 2016, when licensees reported a gaming win of \$861,137,241. For the fiscal year (July 1, 2017 through August 31, 2017), gaming win has increased 5.90%.

# Percentage Fee Collections for the Month of September 2017

The State collected \$50,426,329 in percentage fees during the month of September 2017\*, based upon the taxable revenues generated in August 2017. This represents a 6.09% (or \$2,895,476) increase compared to the prior year's September, when percentage fee collections were \$47,530,853.
