Nevada Gaming Revenues and Collections

Win Revenue Summary – August 2019

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$952,404,403 for the month of August 2019. This amounts to a 4.30% <u>increase</u> compared to August 2018, when licensees reported a gaming win of \$913,099,059. For the fiscal year (July 1, 2019 through August 31, 2019), gaming win has increased 3.57%.

Percentage Fee Collections for the Month of September 2019

The State collected \$50,066,196 in percentage fees during the month of September 2019*, based upon the taxable revenues generated in August 2019. This represents a 6.92% (or \$3,239,031) <u>increase</u> compared to the prior year's September, when percentage fee collections were \$46,827,165.
