**Win Revenue Summary - August 1998**

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$685,165,061 for the month of August 1998. This amounts to a 0.21% increase compared to August 1997, when licensees reported a gaming win of \$683,697,659.

**Percentage Fee Tax Collections for the Month of September 1998**

The State collected \$37,285,981 in percentage fee taxes during the month of September 1998, based upon the taxable revenues generated in August 1998. This represents a 0.35% (or -\$129,823) decrease compared to the prior year's September (1997), when percentage fee collections were \$37,415,804.

On a three-month fiscal-year-to-date (July 1, 1998 through September 30, 1998), the State of Nevada collected \$114,787,525 in percentage fee taxes. This represents a 7.46% increase from the prior fiscal year three-month period when collections totaled \$106,819,040.
