December 2003 Nevada Gaming Revenues and Collections

Win Revenue Summary – December 2003

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$767,314,703 month of December 2003. This amounts to a 1.02% <u>decrease</u> compared to December 2002, when licensees reported a gaming win of \$775,230,715. For the fiscal year (July 1, 2003 through December 31, 2003), gaming win has increased 1.29%.

Percentage Fee Collections for the Month of January 2004

The State collected \$39,357,948 in percentage fees during the month of January 2004, based upon the taxable revenues generated in December 2003. This represents a 4.83% (or \$1,814,577) increase compared to the prior year's January (2003), when percentage fee collections were \$37,543,371. During the 20th Special Legislative Session percentage fee rates were increased by 8.6%, which should be taken into consideration when making comparisons with the prior fiscal year. The new percentage fee rates became effective in September.

Fiscal Year 2004 Forecast

Compared to the May 2003 Economic Forum's projections, percentage fee collections for the total of the first seven months of fiscal year 2004 are 3.1% above their forecast. However, for the current month collections were 9.3% below their forecast. These calculations include the increase in percentage fee rates passed during the 20th Special Legislative Session.
