December 2006 Nevada Gaming Revenues and Collections

Win Revenue Summary – December 2006

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,062,752,779 for the month of December 2006. This amounts to a 17.08% <u>increase</u> compared to December 2005, when licensees reported a gaming win of \$907,705,742. For the fiscal year (July 1, 2006 through December 31, 2006), gaming win has increased 7.22%.

Percentage Fee Collections for the Month of January 2007

The State collected \$51,147,806 in percentage fees during the month of January 2007, based upon the taxable revenues generated in December 2006. This represents a 17.84% (or \$7,744,218) <u>increase</u> compared to the prior year's January, when percentage fee collections were \$43,403,588.
