Win Revenue Summary - December

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$751,309,543 for the month of December 1999. This amounts to a 9.97% increase compared to December 1998, when licensees reported a gaming win of \$683,200,834.

Percentage Fee Tax Collections for the Month of January 2000

The State collected \$34,610,960 in percentage fee taxes during the month of January 2000, based upon the taxable revenues generated in December 1999. This represents a 9.38% (or \$2,968,653) increase compared to the prior year's January (1999), when percentage fee collections were \$31,642,307.

On a seven-month fiscal-year-to-date (July 1, 1999 through January 31, 2000), the State of Nevada collected \$309,420,588 in percentage fee taxes. This represents a 15.52% increase from the prior fiscal year seven-month period when collections totaled \$267,849,749.
