**Win Revenue Summary – February 2001**

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$698,855,835 for the month of February 2001. This amounts to a 7.02% decrease compared to February 2000, when licensees reported a gaming win of \$751,613,498.

**Percentage Fee Tax Collections for the Month of March 2001**

The State collected \$44,002,761 in percentage fee taxes during the month of March 2001, based upon the taxable revenues generated in February 2001. This represents a 10.26% (or \$4,096,225) increase compared to the prior year's March (2000), when percentage fee collections were \$39,906,536.

On an nine-month fiscal-year-to-date (July 1, 2000 through March 31, 2001), the State of Nevada collected \$401,688,785 in percentage fee taxes. This represents a 1.03% decrease from the prior fiscal year nine-month period when collections totaled \$405,871,581.
