February 2002 Nevada Gaming Revenues and Collections

Win Revenue Summary - February 2002

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$752,609,255 for the month of February 2002. This amounts to a 7.76% increase compared to February 2001, when licensees reported a gaming win of \$698,436,593.

Percentage Fee Tax Collections for the Month of March 2002

The State collected \$42,253,583 in percentage fee taxes during the month of March 2002, based upon the taxable revenues generated in February 2002. This represents a 3.94% (or \$1,735,177) decrease compared to the prior year's March (2001), when percentage fee collections were \$43,988,760.

On a nine-month fiscal-year-to-date (July 1, 2001 through March 31, 2002), the State of Nevada collected \$388,029,770 in percentage fee taxes. This represents a 3.40% <u>decrease</u> from the prior fiscal year nine-month period when collections totaled \$401,674,784.
