
# February 2003 Nevada Gaming Revenues and Collections

#### Win Revenue Summary – February 2003

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$756,139,379 for the month of February 2003. This amounts to a 0.45% increase compared to February 2002, when licensees reported a gaming win of \$752,758,057.

#### **Governor's Comments**

"With the start of the war in Iraq and the uncertainty as to its length, I am very concerned on how much additional pressure this will put on our fragile tourist-based economy. Percentage fee collections are currently \$16.9 million below the May 2001 Economic Forum's forecast and this shortfall could increase over the remaining months of this fiscal year adding to the State's overall budget deficit".

### Fiscal Year 2003 Economic Forum Forecast

Comparing to the May 2001 Economic Forum's projections, percentage fee collections through the first nine months of fiscal year 2003 are \$16.9 million below their forecast. Percentage fee collections will need to increase by over 20% percent per month in order to meet the Economic Forum's projection. The State's budget for fiscal year 2003 is required by law to be built using the Forum's projections.

#### Percentage Fee Tax Collections for the Month of March 2003

The State collected \$47,962,404 in percentage fee taxes during the month of March 2003. This represents a 13.51% (or \$5,709,056) increase compared to the prior year's March (2002), when percentage fee collections were \$42,253,348. Percentage fee tax collections can vary widely from month to month because the tax is paid three months in advance and adjusted monthly thereafter.

On a nine-month fiscal-year-to-date (July 1, 2002 through March 31, 2003), the State of Nevada collected \$411,061,478 in percentage fee taxes. This represents a 5.94% increase from the prior fiscal year nine-month period when collections totaled \$388,029,535. Comparing to the same nine-month period in fiscal year 2001, collections have only increased 2.34%.
